### **BOOK SYNOPSIS**

Alex Gino, the Lambda Literary Award-winning author of *Melissa*, is back with another sensitive tale based on increasingly relevant social justice issues.

Jilly thinks she's figured out how life works. But when her sister, Emma, is born deaf, she realizes how much she still has to learn. The world is going to treat Jilly, who is white and hearing, differently from Emma, just as it will treat them both differently from their Black cousins.

A big fantasy reader, Jilly makes a connection online with another fantasy fan, Derek, who is a Deaf, Black ASL user. She goes to Derek for help with Emma but doesn't always know the best way or time to ask for it.

As she and Derek meet in person, have some really fun conversations, and become friends, Jilly makes some mistakes . . . but comes to understand that it's up to her, not Derek, to figure out how to do better next time -- especially when she wants to be there for Derek the most.

Within a world where kids like Derek and Emma aren't assured the same freedom or safety as kids like Jilly, Jilly is starting to learn all the things she doesn't know--and by doing that, she's also working to discover how to support her family and her friends.

### **RESPONSE TO CHALLENGES**

<u>We Need Diverse Books</u>: We Need Diverse Books and Florida Freedom to Read Project are writing to you on behalf of the undersigned authors and illustrators concerning the repeated challenges against LGBTQ+ books at Alachua County Schools. The following titles, which have received critical acclaim and national awards, are being targeted and threatened with removal, simply for reflecting the lives of the LGBTQ+ community.

We Need Diverse Books (WNDB) is especially alarmed that several of these authors are directly connected to our organizations. At WNDB, Alex Gino was one of our longstanding volunteers and Kyle Lukoff was a mentor in our annual Mentorship program. Akwaeke Emezi also received our Walter Dean Myers Honor in 2021 for their novel Pet.

Those of us representing Florida Freedom to Read Project (FFTRP), a group led and supported by public school parents, are extremely concerned that the ongoing, targeted attacks unfairly put pressure on individual educators to defend access to books that represent our diverse and inclusive communities in Alachua County. These books do not violate the law, and it's a travesty that the district must suffer the expense of entertaining these intolerant viewpoints for even one committee review, let alone the hearings and Board Meeting time [...]

We are writing to you today to speak up for the affected teachers, media specialists, and children; and to affirm the transformative power of diverse literature. Studies show that diverse books can build empathy and reduce prejudice, creating a more compassionate world for our kids to grow up in. And as hate crimes spike across the U.S., we need these books now more than ever.
