RESPONSE TO CHALLENGES

Liza Porras, student at Nesbitt Discovery Academy in Buncombe, NC: Multiple times, books with sexual subject matter have been referred to as pornography at school board meetings by those seeking to ban them. Sometimes, as in the case of *Doing It!*, the book presents sex matter-of-factly as a sexual education tool. Other times, passages with sexual acts are presented to the board out of context, even though the book is actually about something else. [Link to article]

In response to Iowa law banning books with descriptions or depictions of sex acts: The Iowa City Community School District plans to permanently remove at least 68 books from local libraries in early 2024 to comply with Senate File 496. [Link to article]

Jonathan Friedman, director of free expression and education programs at PEN America, on Collier County School District in Florida's decision to ban titles: This alarming development is just the latest in an onslaught of attacks against students' freedom to read in Florida. Even if access to these books is not technically restricted, the labeling of these books risks attaching a stigma to the topics they cover and the books themselves. Under the guise of 'parental rights,' interest groups have been empowered by opportunistic elected officials and are now hijacking public schools. Every child deserves the right to learn from a diverse set of voices and perspectives, and to freely access the books they wish to read. [Link to article]

Weston County Attorney Michael Stulken on criminal charge raised against Campbell County Public Library: In a letter to the Campbell County Sheriff's Office, Stulken describes that the law refers to those who encourage someone "to engage" in sexual intrusion. Because the materials are disseminated to the general public, there is no "engagement." He also states that with regards to obscenity, the books at issue are not obscene as defined by Wyoming Law and may have scientific value. [Link to article]
